

2025 Cumberland Communications Survey Giveaway Terms and Conditions

1.Application

1.1. Information on how to enter the 2025 Cumberland Communications Survey Giveaway (**Giveaway**) and a description of the prizes form part of these Terms and Conditions.

1.2. By entering this Giveaway, You agree to be bound by these Terms and Conditions.

1.3. The promoter is Cumberland City Council (Council), of 16 Memorial Avenue, Merrylands.

1.4. This Giveaway is a gratuitous lottery based on completion of a government survey and does not require a permit. For more information refer to NSW Fair Trading website.

2.Eligibility and how to enter

2.1. The Giveaway commences at 9:00am (AEDT) on Friday 7 February 2025 and concludes at 5:00pm on Monday 30 June 2025 (AEST) (**Promotional Period**).
