- One Winner in each ward will receive a \$500 gift card, one Runner Up in each ward will receive a \$200 gift card and one Highly Commended in each ward will receive a \$100 gift card.

## **TERMS AND CONDITIONS**

### 1. Application

- **1.1.** Information on how to enter the Christmas Lights (Competition) and a description of the prize form part of these Terms and Conditions.
- **1.2.** By entering the Competition, you agree to be bound by these Terms and Conditions.
- **1.3.** The promoter is Cumberland City Council (Council), located at 16 Memorial Avenue, Merrylands, NSW.
- **1.4.** This Competition is a gratuitous lottery (game of skill) and does not require a permit under NSW law. For more information, refer to the NSW Fair Trading website.

- **3.3.** Voting then will be open to residents to pick their favourite images from the ten shortlisted entries for each of the five wards. Individuals who vote will have their names put into a draw to win a \$50 youcher.
- **3.4.** The nominee/s who put forward the **winning** image that received the most votes, will win a **\$500** voucher.
- **3.5.** The nominee/s who put forward the **runner-up** image that received the most votes, will win a **\$250** voucher.
- **3.6.** The nominee/s who put forward the **highly commended** image that received the most votes, will win a **\$100** voucher.
- 3.7. Winners will be notified by phone and/or email by Friday, 16 January 2026.
- **3.8.** After 7 days, unclaimed prizes will be forfeited.
