Other Mayoral Facilities

Staff: A personal assistant has provided clerical support on a full-time basis during the period.

<u>Mayoral Vehicle:</u> A fully serviced and maintained vehicle with a value (inclusive of GST) below the Luxury Car Tax (LCT) threshold for official civic duties and incidental use was utilised by the Mayor from 20 March 2018 – 30 June 2018 in accordance with Council's *Fleet Management Policy* and *Councillor Expenses and Facilities Policy*.

<u>Parking:</u> A Mayoral car parking space was available to the Mayor to park in the Auburn Administration Building and Merrylands Administration Building during this period.

<u>Office:</u> A furnished office was available to the Mayor during the period in the Merrylands Administration Building.

Other Councillor Facilities

<u>Meals:</u> Councillors are provided with a meal and refreshments, excluding alcohol, prior to Council meetings and Councillor briefings.

<u>Parking</u>: Parking spaces are available to Councillors to park in the Auburn Administration Building, Merrylands Administration Building and the Granville Town Hall. In addition, access to the public car park adjoining the Council administration building in Auburn is available for any Councillors on request.

<u>Office:</u> A furnished Councillors room with light refreshments is provided in the Auburn Administration Building, Merrylands Administration Building and the Granville Town Hall.

<u>Uniform:</u> On request Councillors are provided with a Council branded uniform and name badge to be worn at civic functions indicating that the wearer holds the office of Mayor, Deputy Mayor and/or Councillor once per Council term.
