

Youth Program Terms & Conditions

Eligibility Requirements

(cross out as applicable to the Program or Activity)

1. All Participants must be a minimum of 12 years old and either live, work, study or have connections to the Cumberland City Local Government Area.

**or*

All Participants must be between the ages of 15-25 and either live, work, study or have connections to the Cumberland City Local Government Area.

2. I confirm that I am over 12 years old.

**or*

I, the parent/guardian, confirm that the Participant is over 12 years old, and I am fully liable for providing incorrect information about the Participant's age.

3. I agree that all information provided on the online registration form, and on this form, is correct and understand any false information will have me/my child removed from the Program and all future Programs and Activities.

If the Participant is under the age of 16, parents/guardians must stay onsite for the duration of the Program or Activity.

Behaviour

1. I agree to listen, participate and respect the youth workers, other youth participating in the Program or Activity, the community and any staff who are also in attendance at the location of the Program or Activity.
2. I will not use any violence or inappropriate language towards the youth workers, other youth participating in the Program or Activity, the community and any staff who are also in attendance at the location of the Program or Activity.
3. I will not misbehave or be disrespectful towards the youth workers, other youth participating in the Program or Activity, the community and any staff who are also in attendance at the location of the Program or Activity.

Cumberland City Council ('**Council**') reserves the right to remove any Participant from the Program when staff or an instructor believes the Participant presents a safety concern, is disruptive, or acts in any manner that is detrimental to the Program or Activity.

Commencement Time

1. I agree to contact Council at least 48 hours prior to the scheduled date of a Program or Activity to notify them of a cancellation of my booking/my child's booking.
2. I agree that I will arrive/my child will arrive at least 10 minutes prior to the commencement of the Program or Activity.
3. I understand that the Program or Activity will proceed without me/my child if I am/my child is late.
4. If I arrive/my child arrives more than 10 minutes late to the Program or Activity, I understand my spot/my child's spot may be given to someone else.

Food Allergies

Please inform the Council of any food allergies or dietary restrictions during online registration.

Liability

1. I understand that the Council and its Service Provider are not liable for any loss or damage to personal property which is suffered, or for any personal injury suffered or sustained in connection with the Program or Activity.
2. I understand that I am/my child is responsible for their own personal belongings.

The Council and its Service Provider do all things reasonably necessary to minimise any risk of personal injury to all Participants.

Emergency

1. I authorise Council staff, where it is impractical to communicate with me, to arrange for my child/ren to receive any medical or surgical treatment/s that may be required; and
2. I undertake to pay or reimburse Council for all costs which may be incurred for medical attention, ambulance transport and medication as a result of my child participating in the Program or Activity.

Please inform the Council of any medical requirements or conditions during online registration.

Personal Information and Privacy

Any personal information provided by you on the online registration form, and on this form, will be used by Council or its agents to process this application.
